The Welcome Home Special APR Program ends on March 5, 2012 for Toyota vehicles and on February 29, 2012 for Lexus vehicles. The Rebate program ends January 2, 2013 for Toyota and March 31, 2012 for Lexus.

To qualify, some of the conditions customers must meet include:

- •Eligible customers must be on current active duty status in the U.S. Military (Navy, Army, Air Force, Marines, National Guard, Coast Guard and active Reserve) or U.S. Military inactive Reserve (Individual Ready Reserve, Selected Reserve, or Inactive National Guard.) Retired Military Personnel are not eligible;
- •Verifiable proof of military status or proof of active service is required at time of purchase;
- •Receive a salary sufficient to cover ordinary living expenses and vehicle payments; and
- •Credit approval through a participating dealer and Toyota Financial Services/Lexus Financial Services.
